### **Ethics Program Monthly Report**

Ms. Dorsey White provided an update on the activities in the Ethics Office for March 2023. She reported that she provided ethics training to 21 new employees as part of the onboarding process.

Ms. Dorsey White shared that the Ethics Office provided guidance on 24 matters, of which the leading categories were Disclosure Statements and Lobbying Activity.

### CY 2022 Ethics Program Annual Report

Ms. Dorsey White provided a final version of the annual ethics report. She stated that the report will be presented at the April 19, 2023 Commission meeting. After approval it will be sent to the County Councils, County Executives, and State Ethics Commission. She added that she is required to submit a signed certification that the report was distributed and published by April 30, 2023.

Ms. Dorsey White reminded the Board that Dr. Hausman will attend the Commission meeting in place of Chair Pruden to present the annual report. She stated that she would provide a script for his presentation.

### **Selection of Board Chair**

Ms. Dorsey White informed the Board that they need to vote on reappointing George Pruden as Chair. The resolution will be considered at the April 19, 2023 Commission meeting.

On motion of Dr. Hausman and seconded by Mr. Hysen, three members of the Board (Hausman, Hysen, and Slaughter) voted to reappoint George Pruden as Chair. Mr. Pruden abstained from voting as he was the nominee.

## Annual Disclosure Launch

Ms. Dorsey White provided details on the implementation of this year's financial disclosure system. She stated that the contract with the current vendor was set to expire on March 31, 2023. Due to issues with renewing the contract, the launch was delayed until April 5, 2023. The deadline for completion is April 30, 2023. She shared that approximately 400 employees have submitted their disclosure.

Ms. Dorsey White stated that she added the questions requested by the Board about employees having a financial interest in a business that is either regulated by WSSC, has a contract with WSSC, and/or is a subcontractor to a WSSC prime. She also added a question about the outside employment pre-approval form.
