## **Matters of Discussion**

## **Ethics Program Monthly Report**

Ms. Dorsey White provided an update on the activities in the Ethics Office for April 2023. She reported that she provided ethics training to 15 new employees as part of the onboarding process.

Ms. Dorsey White shared that the Ethics Office provided guidance on 26 matters, of which the leading categories were Disclosure Statements, Soliciting or Acceptance of Gifts, and Outside Employment/Interests.

Further, Ms. Dorsey White provided an update on the annual disclosures filing process. She stated that 374 of approximately 1,700 disclosures are still outstanding, reflecting a completion rate of 75 percent.

Lastly, Ms. Dorsey White shared the quarterly Spotlight on Ethics topic. "Outside Employment/Outside Interests" will be presented at the Commission meeting to be held on May 17, 2023.

## April 2023 Commission Meeting Wrap-Up

Ms. Dorsey White and Dr. Hausman provided a final update on the annual ethics report. Dr. Hausman gave an overview of his experience at the April 19, 2023 Commission meeting. Ms. Dorsey White stated that, after the Commissioners approved the report, it was sent to the County Councils, County Executives, and State Ethics Commission. Additionally, the State Ethics Commission received the

mandatory annual certification that the Commission is in compliance with the Public Ethics Law. Ms. Dorsey White explained that the certification covers conflict of interest and financial disclosure provisions, lobbying activities, and publication of the report.
